5. Applicant agrees to inform Zander Sod Co. Limited in writing within 5 days of any change in ownership, address, telephone or other facts given.
6. The applicant accepts full personal responsibility for payment of goods received unless notification in writing is received by Zander Sod Co. Limited of a change in ownership or incorporation.
7. In the unlikely event that quality of material shipped is below standard expected, such claims must be made with 24 hours of delivery.
8. Claims for adjustments on invoices received by the customer must be made within 10 days.
9. Guaranty: In consideration of the approval of this credit application, and for other good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned party ("guarantor") unconditionally guarantees to Zander Sod Co. Limited (the "supplier") the full and prompt payment by the Applicant of all accounts and invoices issued to the Applicant by the Supplier subsequent to the acceptance by the Supplier of the Credit Application, and agrees to indemnify the Supplier or its Assignee against any loss the Supplier may incur resulting from the failure by the Applicant to pay such accounts and invoices.
